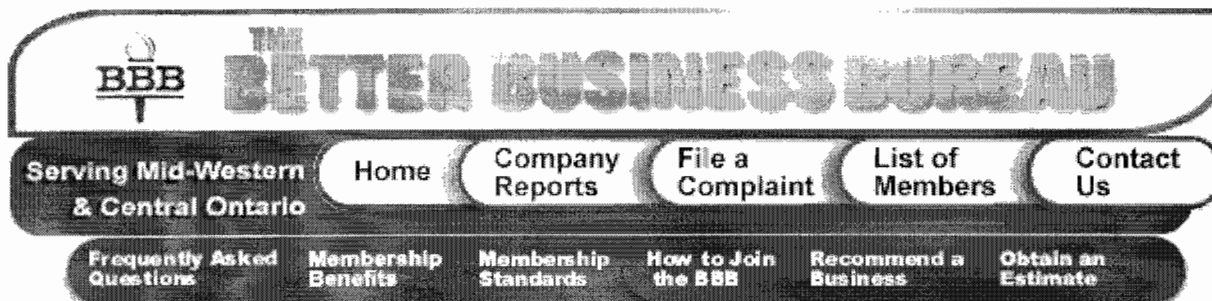

Based on BBB files, this company has an **unsatisfactory record** with the Bureau due to a **pattern** of complaints and has failed to correct the underlying reason for the complaints.

The company is not located at 80 Queen St N like they state, this address is the home of the Greater Kitchener Waterloo Chamber of Commerce and they confirm this company is not located at this address.

Consumers should be aware that the cashiers cheque that the company sends to consumers are fraudulent. The company sends consumers a cheque for approximately \$5,000 telling them to keep approximately \$1,000 and to spend approximately \$50 buying items at a local business and send the remaining money back to a contact person, through a money transfer service. The problem is the cheque is counterfeit and victims are left on the hook for the entire amount, after the fact.

When considering complaint information, please take into account the company's size and volume of transactions, and understand that the nature of complaints and a firm's responses to them are often more important than the number of complaints.

The Bureau processed a total of 7 complaints about this company in the last 36 months, our standard reporting period. Of the total of 7 complaints closed in 36 months, 7 were closed in the last year.

While ads claim high earnings and short hours with little or no experience, Bureau files nationwide indicate no evidence of anyone making the promised money. Rarely, if ever are these ads an offer of legitimate employment. Generally, these "jobs" require up-front fees for information or supplies, and only the person who ran the ad makes any money.
